Whereas Gwaihir Stud has agreed to accept the mare.....
(Reg No.....) owned by the Mare owner/lessee for chilled semen insemination from the stallion
Gwaihir Aubusson upon the terms and conditions hereinafter appearing.

1. Charges

1.1 The Service fee of \$1,250 (inc. GST) for the 2010 season, is payable with this contract, and includes one collection. Any additional collections will be charged at @\$450, excluding the container and transport expenses (both of which are always the expense of the mare owner.)

1.2 A copy of the front and back of the Mare's Breed Registration Certificate/s (AWHA, AHSA, ACE, ASH, AWSHA) must accompany the booking/handling fee and this contract.

2. Mare Owner/lessee's Obligations

2.1 The Mare Owner/lessee undertakes to employ the services of an accredited artificial insemination equine breeding veterinarian listed by the Australian Equine Veterinary Association.

2.2 The Mare Owner/lessee establishes the breeding suitability of the mare prior to insemination.

2.3 The Mare Owner/lessee undertakes to liaise directly with Gwaihir Stud regarding delivery of chilled semen with due notice.

3. Gwaihir Rights and Obligations

3.1 With this service Gwaihir Stud will cover the collection fee for the semen and all other costs incurred up to the point of transport (for the first collection.) It is at the mare owner's expense, that the semen is transported from our stud to its final destination, and then inseminated into the mare.

3.2 The manager of Gwaihir Stud reserves the right to refuse any mare for service.

3.3 It is further agreed that should the stallion die or become unfit for service; or if the owners mare should die; then this contract shall become null and void. Any money paid as booking fee shall be refunded to the mare owner.

3.4. It is agreed that all sums shall be paid to 'Gwaihir Stud', PO Box 805, Bowral NSW 2576. If any outstanding amounts are not paid within 30 days of their due date then Gwaihir Stud shall have a lien over the resultant progeny (if the mare conceives) or the mare (if the mare does not conceive), and may exercise all rights pursuant hereto.

4. Live Foal Guarantee

There is a live foal guarantee for mares, due to a live foal not resulting in the previous season, if the mare aborts after returning a 45-day positive pregnancy test, or if the foal dies within 24 hours of foaling or if the foal is stillborn, in all cases to be certified by a veterinary surgeon. Veterinary certification must also be provided to the effect that the dead foal was the result of insemination by Gwaihir Aubusson. We will supply another dose for the mare named above for \$450. Container, transport and veterinary costs will be at the mare owner's expense.
