



Gwaihir Aubusson Service Agreement (Frozen)

Whereas Gwaihir Stud has agreed to accept the mare..... (Reg No.....)
 owned by the Mare owner/lessee for frozen semen insemination from the stallion **Gwaihir Aubusson** upon the
 terms and conditions hereinafter appearing.

1. Charges

1.1 Charge for three (3) inseminations/ doses of frozen semen for the 2011 season is \$1,100.00 including GST, to be paid in advance.

1.2 The Mare Owner agrees to pay all additional charges, veterinary costs, packaging and transport costs, to Gwaihir Stud.

1.3 A copy of the front and back of the Mare's Breed Registration Certificate/s (AWHA, AHSA, ACE, ASH, AWSHA) must accompany this contract.

2. Mare Owner/lessee's Obligations

2.1 The Mare Owner/lessee undertakes to employ the services of an accredited artificial insemination equine breeding veterinarian listed by the Australian Equine Veterinary Association.

2.2 The Mare Owner/lessee establishes the breeding suitability of the mare prior to insemination.

2.3 The Mare Owner/lessee undertakes to liaise directly with Gwaihir Stud regarding delivery of frozen semen with a minimum of 7 days notice.

3. Free Return

3.1 The mare named in this contract is entitled to one (1) free return of a maximum of two (2) doses, to be provided one (1) at a time, if the mare aborts after returning a 45-day positive pregnancy test, or if the foal dies within 24 hours of foaling or if the foal is stillborn, in all cases to be certified by a veterinary surgeon. Veterinary certification must also be provided to the effect that the dead foal was the result of insemination by Gwaihir Aubusson

3.2 Free return is not applicable should a foal die of accidental causes, or through negligence.

3.3 Free return is only applicable if all initial straws have already been used in the process of impregnating the mare named in this contract.

3.4 Free return is only available in the year immediately following the initial insemination and subject to availability.

3.5 If the mare dies, is unsuitable to breed or is sold, Clause 3 becomes null and void.

4. Gwaihir Rights and Obligations

4.1 Gwaihir reserves the right to refuse sale of frozen semen to any mare owner at its discretion.

4.2 Gwaihir reserves the right to refuse to participate in any registration process for a foal born by using Gwaihir Aubusson's frozen semen to impregnate a mare which has not been previously authorised by Gwaihir Stud.

5. Multiple pregnancies from one shipment of frozen semen

5.1 The mare owner will be supplied with a minimum of three doses for their mare; should the mare conceive before all the straws are used, the remaining straws can be used to (a) impregnate another mare; (b) impregnate the same mare the following season; or, (c) save them as a personal LFG. However should the mare owner have two or more foals as a result of the semen sent as per this contract, then the said mare owner has an obligation to inform Gwaihir Stud of this outcome and pay an additional \$220 per foal (not including the initial foal bred.) Breeding registrations and service documents will then be issued for this/ these extra foal/s.
